1. To accept, sign and/or endorse, as applicable, checks, drafts, notes, bills, acceptances or other orders for the payment of money, certificates of deposit or other instruments on behalf of the Trust;
2. To waive demand, protest and notice of protest or dishonor of any check, note, bill draft or other instrument made, drawn or endorsed on behalf of the Trust;
3. To request, execute, deliver and utilize any loans. The Trustee(s) shall comply with each of the provisions of the loans on behalf of the Trust, and otherwise bind the Trust as set forth in the loan documents and any and all other documents required by Bank to evidence and/or secure the loan to the Trust. All actions of the Trustee(s) and other authorizations necessary or appropriate for the execution and delivery of and compliance with the loan documents have been taken or obtained, and the loan documents constitute the valid and legally binding obligations of the Trust enforceable against the Trust in accordance with their respective terms;
4. To enter into and execute any agreements and documents, including this certification, related to the establishment or usage of banking services.

Any such notice shall not affect any of the Trust's agreements or commitments in effect at the time notice is given.
2. **Reliance on This Certification.** Any transaction entered into by a person acting in reliance on this Certification of Trust shall be enforceable against the Trust assets.
3. **Trust Provisions to be Made Available upon Request** -- A recipient of a certification of trust may require the Trustee(s) to furnish copies of those excerpts from the original trust instrument and later amendments which designate the Trustee and confer upon the Trustee all powers to act in the pending transaction.

PART 5: Signature(s) By Trustee(s) - Required

By signing this document, the Trustee(s) verifies that all information contained herein is true and accurate and that SEI Cash Access, the Bank, their affiliates, agents and those that provide instructions or information to SEI Cash Access and/or the Bank on behalf of the Trust may rely upon this information.

The Trustee agrees to indemnify, defend and hold harmless the Bank and its respective directors, officers, employees, agents, successors and assigns from and against any and all claims, demands, harmless losses, liabilities or expenses, including reasonable attorneys' fees (whether or not such attorneys are employees of the Bank or any respective affiliated company), resulting from the Trustee(s)' use of the services with respect to the accounts or the Bank acting on instructions.

Any transaction entered into by a person acting in reliance on this Certification shall be enforceable against the trust assets.
